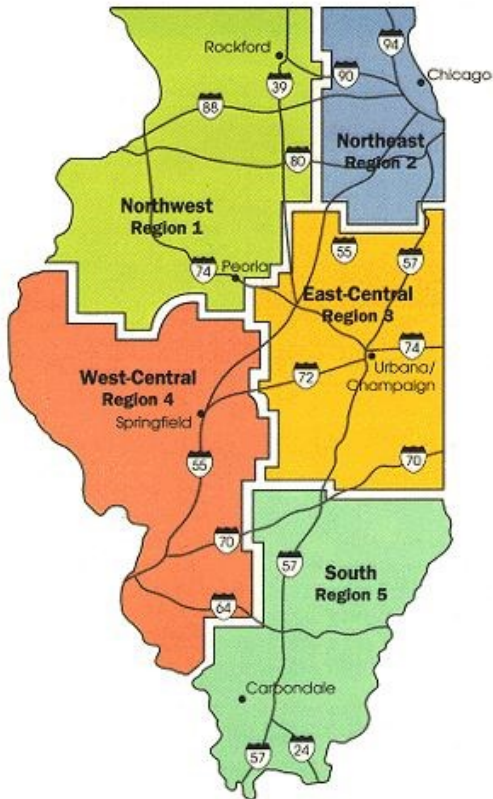


Horsemen's Council of Illinois Represents YOU!

Illinois is the only statewide organization that works to serve the entire horse community.

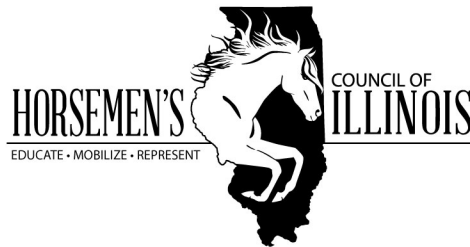
